# Rajasthan

## Advantage Unlimited

Rajasthan is the largest state of India with an area of 342,239 square kilometres, covering 10.4% of the total land mass of the country. According to 2011 Census of India, Rajasthan has a total population of over 68.50 million people, making it a huge manpower pool as well as a large captive market for industries setting up shops here.

## Location Advantage

- ~25% of the National Capital Region (NCR) falls in Rajasthan - one of India's leading economic magnets.
- Rajasthan shares land border with Haryana, Punjab, Gujarat, Madhya Pradesh and Uttar Pradesh - giving industries based in the state direct access to these large markets.
- Rajasthan provides easy access to nearly 40% of India's market by population.





# Connectivity Advantage

Rajasthan has an enviable network of road, rail and air transport; with seamless modes of transportation connected to the rest of India as well as international destinations.

## Highways

- Rajasthan has the third largest network of National Highways in the country.
- Over 50 National Highways totalling more than 10,500 km and 190+ State Highways, spanning over 17,000 km pass through Rajasthan.
- The total road network of the state exceeds 3 lakh kilometres.
- Golden Quadrilateral, East West Corridor, North South Corridor and Delhi-Mumbai Expressway pass through Rajasthan.

## WDFC & DMIC - in Influence Zone

- Nearly 39% of **Dedicated Freight Corridor** (DFC), connecting Delhi to Mumbai providing fast transit of goods to and from the seaports, passes through Rajasthan.
- About 60% of the state's area falls in the project influence area of the DMIC (Delhi Mumbai Industrial Corridor) which lies on both sides of the DFC.
- 5 DMIC nodes have been proposed in Rajasthan.



## Delhi-Mumbai Expressway

The 1,386 km long Delhi-Mumbai Expressway - the longest expressway in the country - passing through the states of Delhi, Haryana, Rajasthan, Madhya Pradesh, Gujarat and Maharashtra is expected to halve the commute time between Delhi and Mumbai from nearly 24 hours to 12 hours. 374 km of the total expressway falls in Rajasthan. This expressway will significantly improve the connectivity to various economic hubs of Rajasthan.



## Bharatmala Corridor

9 out of 44 identified economic corridors of high-quality roads announced by Government of India as a part of the Bharatmala Pariyojana pass through Rajasthan.

## Rail Network

Rajasthan has the 2nd largest rail network in the country with more than 6,000 kilometres of route length providing train connectivity to major Indian cities.

- Jaipur International Airport offers direct connectivity to major Indian cities and international destinations.
- Well-connected airports at Jodhpur, Ajmer (Kishangarh), Udaipur, Jaisalmer, Kota and Bikaner.

## Logistic Infrastructure

- World-class Multi-Modal Logistic Park operational at Khatuwas (Neemrana) and many more Multi-Modal Logistic Parks are on the anvil.
- Strong network for industrial and logistics units located in the state:
  - Air Cargo Complex at Jaipur.
  - Inland Container Depots at Jaipur, Kotputli-Behrore (Khatuwas), Jodhpur/Jodhpur (Rural), Bhilwara, Bhiwadi and Kota.

## Resource Advantage Mineral Resources

Rajasthan is the richest state in terms of availability and variety of minerals in the country and produces about 57 different minerals, offering opportunities in mining, extraction and value addition.

- 90% to 100% share in the production of Lead & Zinc ore, Wollastonite, Calcite, Gypsum, Rock Phosphate, Ball Clay, Ochre and Silver.
- Largest producer of Marble, Sandstone, Flaggy Limestone in India, with prominent position in Granite and other dimensional stones.
- Largest reserves of Potash and Feldspar in India.
- Largest producer of Crude Oil (onshore drilling) in India.

## Agriculture & Livestock Resources

Rajasthan is richly endowed with a wide variety of crops and in animal husbandry.

- Largest producer of Rapeseed & Mustard, Guar and Total Oilseeds.
- 2nd largest producer of Cumin seed, Carom seed, Fennel seed, Fenugreek seed, Garlic, Groundnut and Total Nutri/Coarse Cereals.
- 3rd largest producer of Gram, Soybean, Coriander seed and Total Pulses.
- Largest producer of Henna and Isabgol.
- 2nd largest livestock.
- 2nd largest producer of Milk.
- Largest producer of Wool.

## Renewable Energy

More than 66% of installed capacity of Rajasthan is through renewable energy sources.

- Rajasthan's solar generation potential has been assessed at 142 GW, with 300 to 330 clear sunny days per year and an average solar incidence of 5-7 KWh/sqm./day.
- Wind energy potential of Rajasthan has been assessed at 284 GW at 150 Mtr. height.





# Gas Grid Advantage

Carrier Gas Pipelines of GAIL supply natural gas to Bhiwadi (and nearby areas of the NCR) as well as Kota, Bundi, Chittorgarh and Bhilwara. The Mehsana – Bathinda – Jammu - Srinagar Carrier Gas Pipeline of GSPL India Gasnet Ltd. (GIGL) passes through the districts of Sirohi, Pali, Jalore, Sanchore, Barmer, Beawar, Ajmer, Dudu, Jaipur (Rural), Sikar, Jhunjhunu, Churu and Hanumangarh.

Strengthening of the gas grid in Rajasthan and awarding of City Gas Distribution Authorisations by the Petroleum & Natural Gas Regulatory Board (PNGRB) has now opened up access to gas-based industries for the entire State. The list of entities authorized (by Geographical Area) is as under:

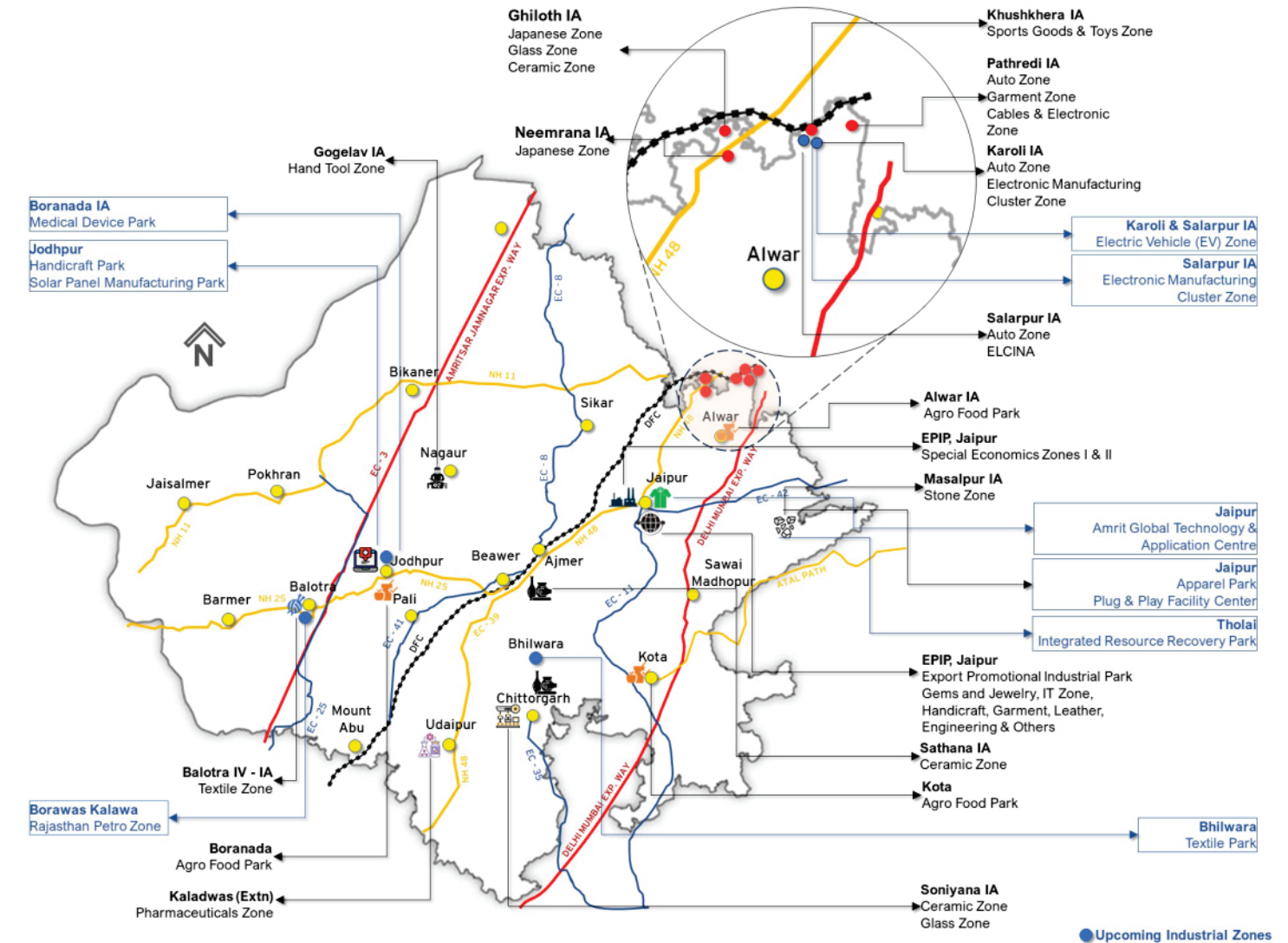

# Rajasthan Petro Zone, Balotra

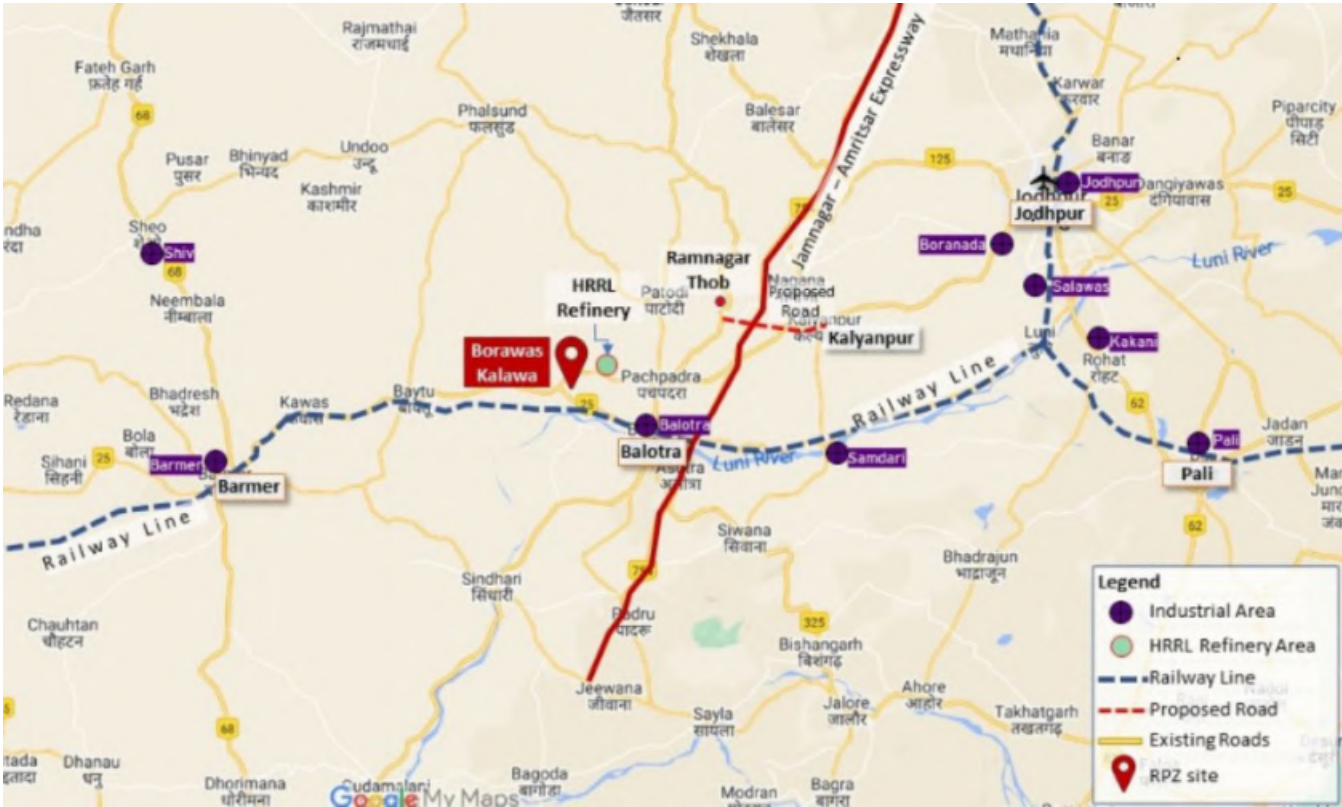
Rajasthan, a prominent location on the world map of Hydrocarbon reserves and production, is on the threshold of turning into an important Petroleum and Petrochemical destination in the country. Rajasthan produces 20% of country's crude oil and enjoys 1st position in onshore drilling. A Greenfield Refinery cum Petrochemical Complex with 9 MMTPA refining capacity and 2.4 MMTPA Petrochemical products is being set up at Pachpadra in Balotra district of Rajasthan, by HPCL Rajasthan Refinery Ltd. (HRRL), which is expected to be commissioned in March, 2025. A wide range of Petrochemical products including Polypropylene, LLDPE/ HDPE,

Butadiene, Benzene and Toluene will be available from the Refinery cum Petrochemical Complex for further value addition through wide range of downstream industries. RIICO is establishing Rajasthan Petro Zone (RPZ) in the vicinity of the Refinery cum Petrochemical Complex, at Borawas Kalawa, primarily for setting up of downstream industries based on the petrochemical products of the Refinery. RPZ is being developed on land area of more than 700 hectare. Government of Rajasthan has allocated 55 MLD water from Indira Gandhi Nahar Pariyojna (IGNP) exclusively for RPZ.

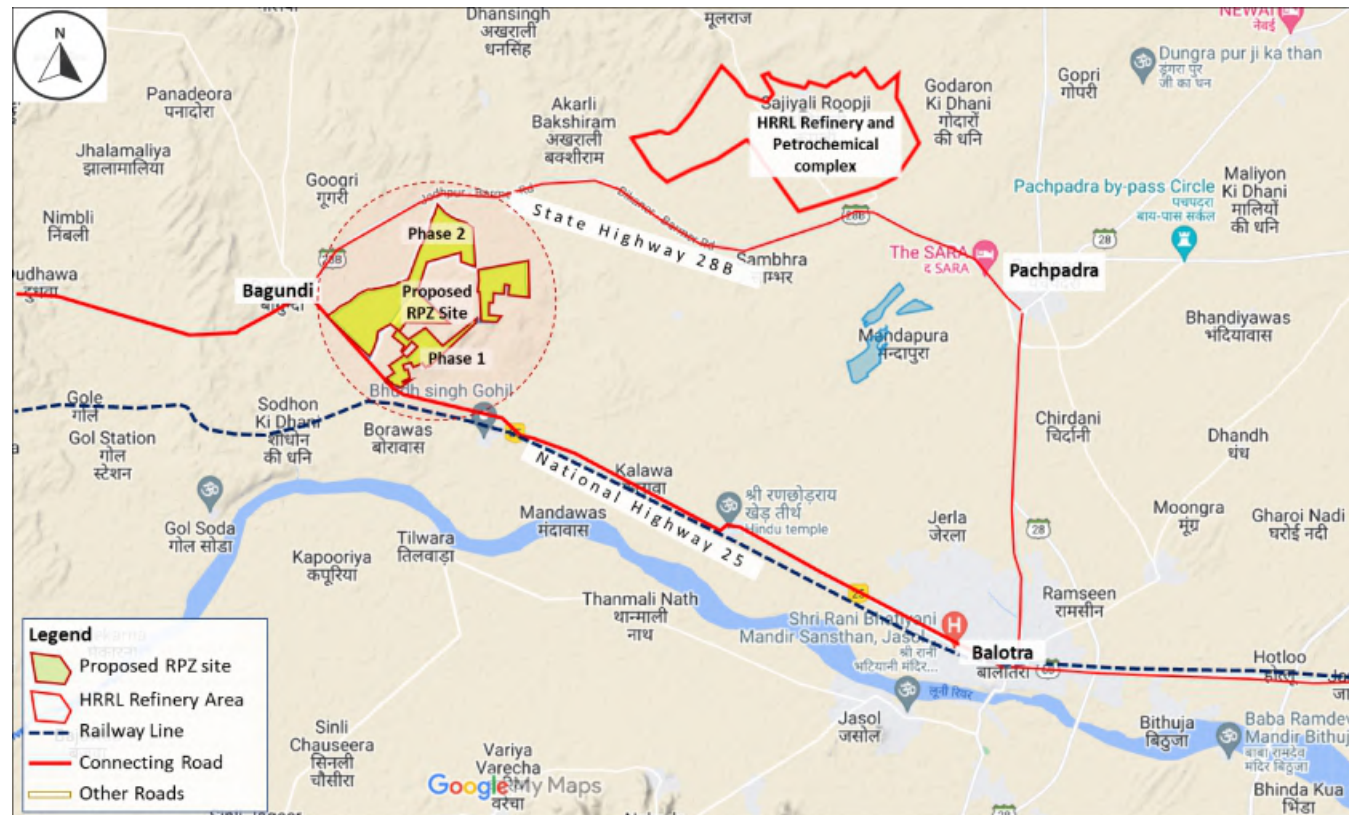

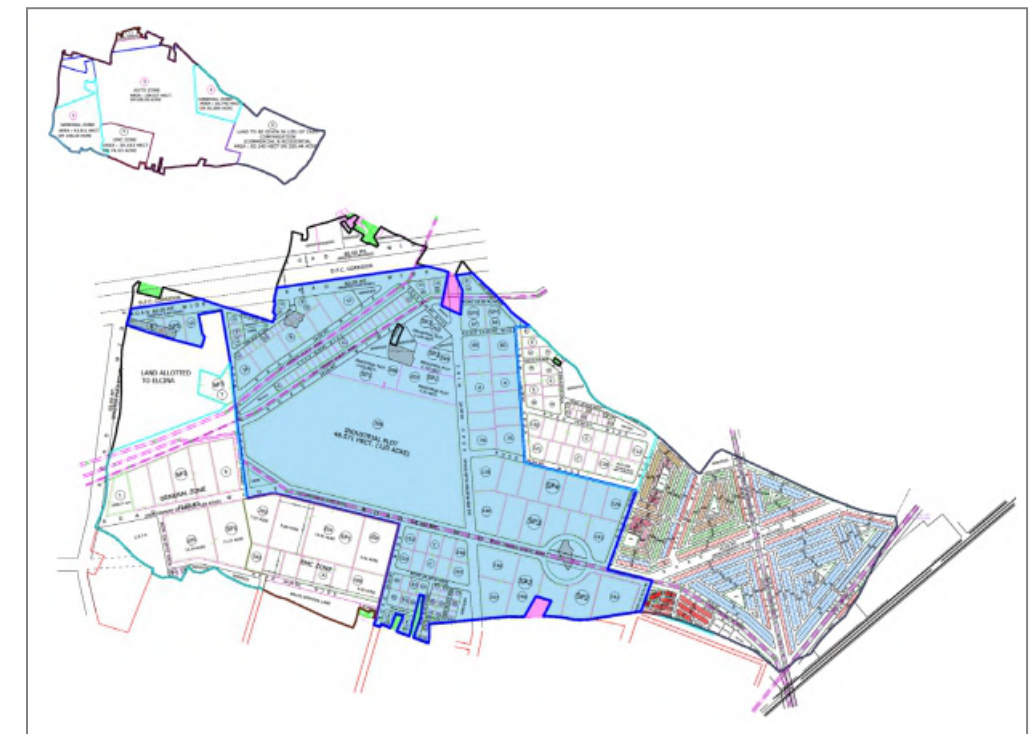

# Electronic Manufacturing Clusters (EMCs), Bhiwadi Region

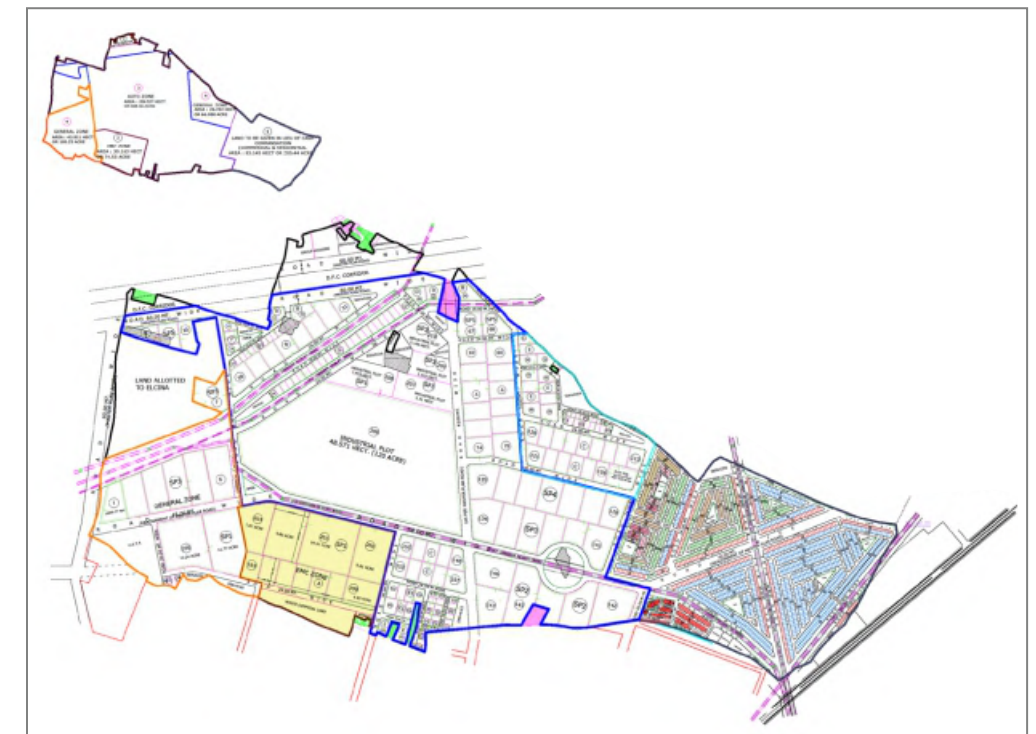
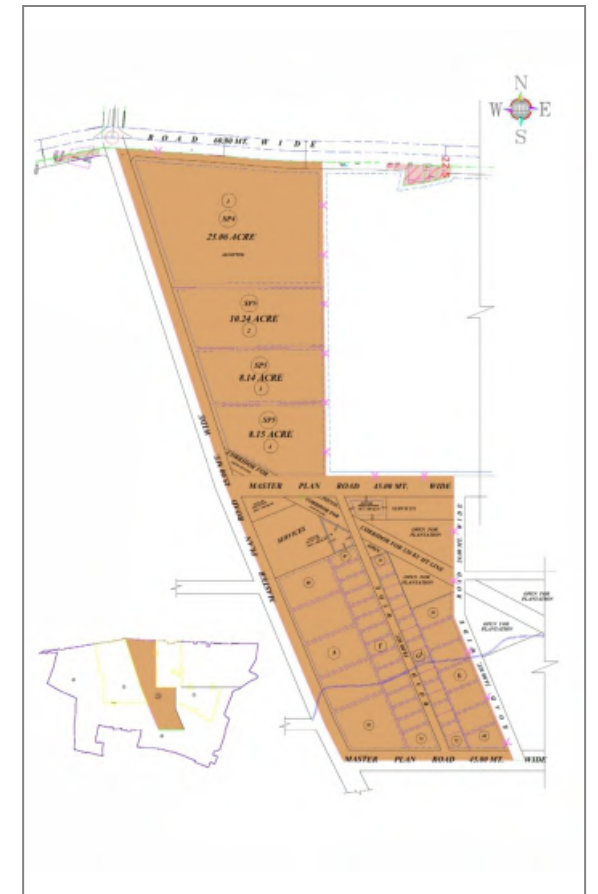
RIICO has developed two Electronic Manufacturing Clusters (EMCs) in Bhiwadi region – one at Karoli Industrial Area and the other at adjoining Salarpur Industrial Area. These EMCs are located in NCR falling in Rajasthan and integrate closely with the ESDM ecosystem in NCR and surrounding areas due to proximity.

Besides, another EMC by ELCINA also exists in Bhiwadi Region in RIICO's Salarpur Industrial Area.

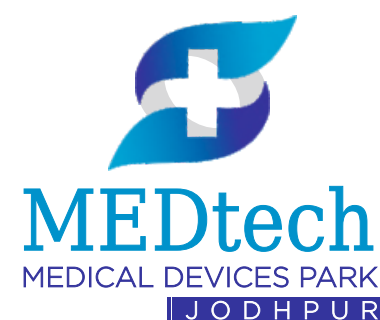

# Medical Device Park, Jodhpur

Rajasthan, a well-known destination for medical tourism, is fast positioning itself as a hub for manufacturing of Medical Devices.



## Dedicated Zone for Medical Devices Manufacturing

RIICO has developed a Medical Device Park named 'MEDtech Medical Device Park, Jodhpur' exclusively for setting up of units for manufacturing of medical devices, in its Boranada Extension Industrial Area at Jodhpur (Rural) district. Boranada Industrial Area is one of the largest industrial areas of Rajasthan.

MEDtech Medical Devices Park is spread over 111 hectare land and 213 plots have been planned in it (1st phase is on 119 acre land with 73 plots).

MEDtech Medical Devices Park is approx. 18 Km from Jodhpur railway station, 4 km from Thar Dry Port and 1 km from NH 25.



## Common Facility Centre in Medical Device Park

RIICO has provisioned a Common Facility Centre (CFC) in the MEDtech Medical Devices Park, for which an area of 6.087 hectare has been earmarked. The CFC is proposed to be equipped with the most advanced common testing and laboratory facilities besides other facilities. RIICO has collaborated with Andhra Pradesh Medtech Zone (AMTZ) at Vishakhapatnam, IIT Jodhpur (IITJ) and Jodhpur City Knowledge & Innovation Foundation (JCKIF) for shaping up CFC.

## Entrepreneurship Development

IITJ and JCKIF will provide support of their Incubation Centres for development of entrepreneurs and startups in MEDtech Medical Devices Park.

# Amrit Global Technology & Application Centre, Jaipur

RIICO is undertaking development of the 'Amrit Global Technology and Application Centre' in Jaipur on a 95 acres land parcel, on the main trunk road of Jaipur viz. Tonk Road, near Jaipur International Airport. The Centre has been envisioned for emerging tech sectors like fintech, financial services, IT, ITeS, artificial intelligence, machine learning, business incubation, plug & play facilities.

Jaipur, home to renowned IT companies and best of educational institutions in the sector, has ready availability of manpower required for the 'Amrit Global Technology and Application Centre'. Well-developed residential, social, institutional and commercial infrastructure is already in place in close vicinity of the location of this Centre.

# Integrated Resource Recovery Park, Tholai, Jaipur

Bhilwara is a renowned Textile manufacturing destination in the country. It is one of the largest producers of Polyester/Viscose blended yarn in the country and also India's #1 location for manufacturing of Polyester Viscose suiting. Bhilwara has also emerged as a leading producer of Denim.

RIICO is in the process of establishing a Textile Park in Bhilwara, which is proposed to be developed on the lines of PM Mega Integrated Textile Region and Apparel Park, on a land parcel of 500+ acre.

# Handicraft Park, Jodhpur

Jodhpur is a leading handicraft & furniture manufacturing destination in the country. Rajasthan contributes a major share in furniture exports from India.

RIICO is in the process of setting up a Handicraft Park over 100 acre land at Boranada Extension Industrial Area in Jodhpur (Rural) district.

# Apparel Park, Near Jaipur

Jaipur, a prominent destination for garment manufacturing for domestic and international markets, houses 700+ apparel manufacturing units. It is predominantly a ladies garment manufacturing destination. Sitapura Industrial Area and Apparel Park are key locations in Jaipur for garment

manufacturing, with about 350 operational units there.

RIICO is contemplating to establish yet another dedicated industrial area/zone for garment manufacturing, near Jaipur.

# Solar Panel Manufacturing Zone, Jodhpur / Pali

Rajasthan is a leading state in the country in renewable energy generation, and offers substantial potential for further addition in renewable energy generation capacities. Rajasthan thus provides a ready captive market for renewable energy equipments.

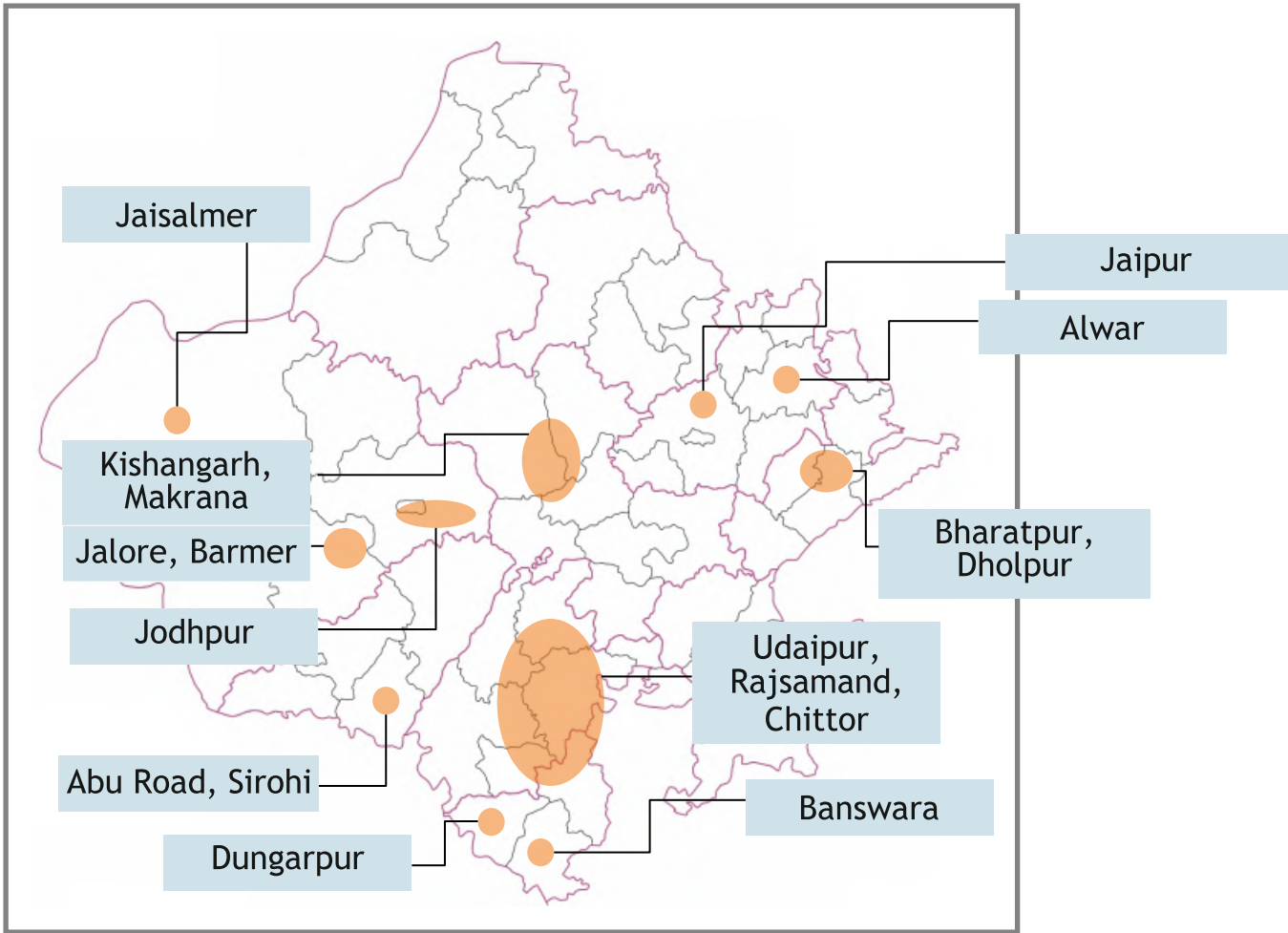
RIICO will be establishing a 'Solar Panel Manufacturing Zone' at Kankani (Jodhpur Rural) / Rohat (Pali)

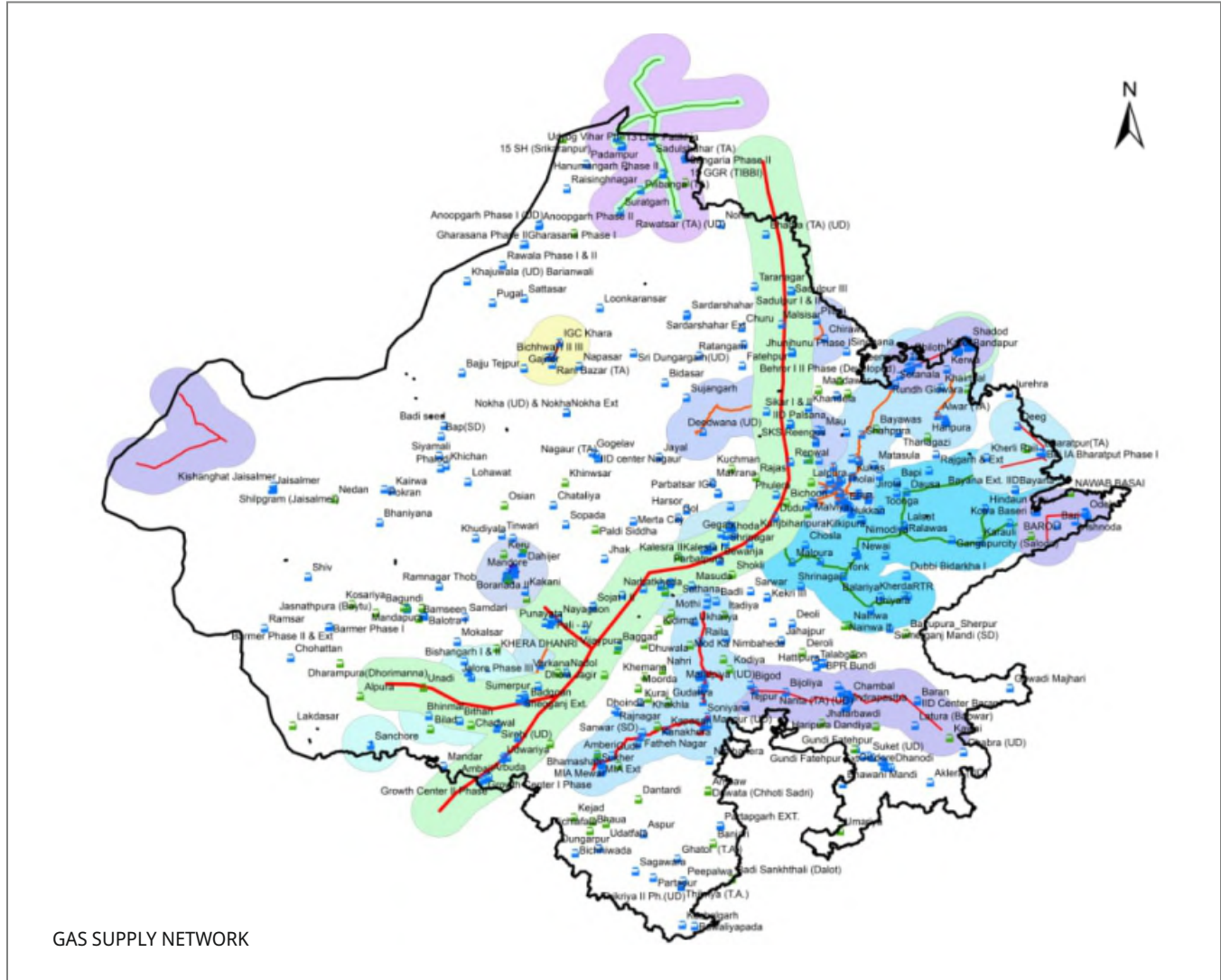
# Industrial Areas for Projects Preferring Natural Gas as Fuel

Rajasthan is the second-largest natural gas producing state in the country. Natural Gas, a clean and cost effective fuel, is a preferred fuel for energy intensive industries like ceramic, glass, metal casting, steel, textile, cement, automobile, fertilizer, refinery, etc.

Mehsana - Bathinda gas pipeline by GSPL India Gasnet Limited passes through Rajasthan. Out of its total network of approx. 1650 km, it traverses

approx. 1334 km in Rajasthan in the districts of Sirohi, Pali, Jalore, Sanchore, Barmer, Beawar, Ajmer, Dudu, Jaipur (Rural), Sikar, Jhunjhunu, Churu and Hanumangarh.

60+ RIICO industrial areas already exist near this gas pipeline, and RIICO is developing many new industrial areas within 5 to 25 Km buffer zone along this gas pipeline route.
