Quorum: - As the quorum was present, the meeting was called to order. The quorum was present throughout the meeting.

Item 1: Confirmation of Minutes of the last meeting of the Committee held on 10th July 2025.

The Minutes of the meeting of the Committee held on 10th July 2025 were noted.

Item 2: Action Taken Report on the decisions of the previous meeting of the Committee held on 10th July 2025.

The Committee noted the position brought out in the Agenda Note.

It was apprised to the Committee on the ATR (Item no.5) that as schedule of appointment of Company Secretary was never sent earlier to FD GoR, therefore proposal to forward the revised schedule to FD was not required. An approval from the Management has also been taken in this regard.



The Committee considered above and further directed that as the experience of Company Secretary required for appointment has been reduced from 10 to 5 years so the scale of Company Secretary shall correspondently be reduced from Grade Pay 7600 to Grade Pay 6600 (L-19 to L-16).

Item 4: Proposal for amendment in RIICO Employee (Term Loan) Rules, 2008.

The Committee discussed the Agenda and accorded approval for amendment in RIICO Employee (Term Loan) Rules, 2008, as follows:

- 1. Term Loan limit be increased from ₹10.00 lakh to ₹20.00 lakh.
- 2. Term Loan interest rate be revised from 9% per annum to 8% per annum.
- 3. Option of partial repayment of Term Loan may be made available to employees. Repayment of a minimum of 20% of the loan amount can be made 3 times during the full repayment period.
- 4. The maximum number of installments must be revised from 120 months to 180 months.



The Committee also directed to entertain the fresh applications only after repayment of earlier loan by the employees.
