


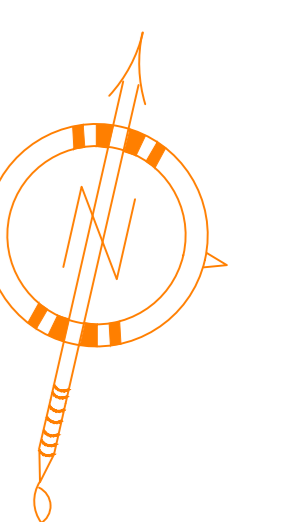
TENTATIVE LAY OUT PLAN FOR DEMARCATION
