TENTATIVE LAY OUT PLAN OF INDUSTRIAL AREA KHODA DISTT. AJMER

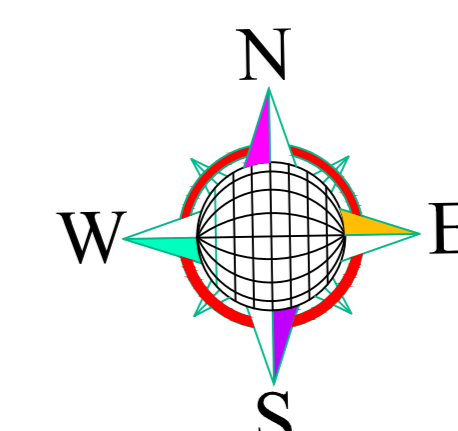
