# Sub: General direction regarding allotment of plots and fixing reserve price for e-Auction of industrial plots.

The IDC in its meeting held on 06.08.2018 has accorded approval for issuing the general directions as under:-

- 1. The allotment of plot shall commence only after construction of roads and demarcation pillars, in order to ensure proper demarcation of plot.
- 2. The allotment of plot should be free from all encumbrances to avoid any litigation in this regard.
- 3. The reserve price fixed for e-auction for industrial plot need not be changed just on the ground that higher bid has been received for a few cases of industrial plots on account of its location or other distinct advantage.

### Sub: Partial amendment in the existing provision of Rule 3(G)-23 of RIICO Disposal of Land Rules, 1979 related to allotment of land for setting up of CNG Station.

An agenda was placed before the IDC vide item (3) in its meeting held on 30.12.2019 and the IDC has accorded partial amendment in the existing rule 3(G)-23 as under:-
