## OFFICE ORDER (13/2020)

## Sub: Policy for allotment of land for Electric Vehicle (EV) Charging Station in RIICO Industrial Areas.

An agenda was placed before the IDC vide item (31) in its meeting held on 24.06.2020. The IDC has accorded approval to make a policy provision under Rule 3(G) of RIICO Disposal of Land Rules, 1979 for allotment of land to Electric Vehicle (EV) charging station in RIICO industrial areas as under;

- (i) Allotment of land (Plot planned by re-planning of service area land) to Public Sector Undertaking/Private Agencies will be made on preferential basis provided that the applicant should have grant of authorization from concerned State Govt. Department/Agency authorized by the State Govt.
- (ii) Rate of allotment for Electric Vehicle (EV) Charging Stations will be 50% of the prevailing rate of allotment of the industrial area concerned.
- (iii) Wherever required, RIICO may also put up its own EV Charging Stations to provide electric vehicle mobility.
- (iv) The Managing Director is authorized for approving allotment of land for this purpose on preferential basis.

Accordingly, the above provision will be inserted as new Rule 3 (G)-27 in RIICO Disposal of Land Rules, 1979, as under:

3 (G)-27	Allotment of land (plot planned by re- planning of service area land) for Electric Vehicle (EV) Charging Station.	At 50% of the prevailing rate of allotment of the industrial area concerned to Public Sector Undertaking/ Private Agencies provided that the applicant should have grant of authorization from concerned

State Government Department/ Agencies authorized by the State Government.
Wherever required, RIICO may also put up its own EV Charging Stations to provide electric vehicle mobility.
The Managing Director is authorized for approving allotment of land for this purpose on preferential basis.
