OFFICE ORDER

Sub: Partial amendment in the decision taken by the IDC vide item (3) of its meeting dt. 13.08.2012 related to reserving the industrial area Kanth-Kalwar (Extn.) for non-polluting use i.e. for Information Technology (IT), institutional, hotel and not to allow any manufacturing activities.

An agenda item (9) was placed before the IDC in its meeting held on 06.08.2019 and the IDC accorded approval for partial amendment in the earlier decision taken by the IDC vide item (3) of its meeting dated 13.08.2012, to the effect that industrial area Kanth Kalwar (Extn.) will be reserved only for non-polluting use, i.e. IT, Institutional, Hotel, Warehousing & Logistics and no manufacturing activity shall be allowed in this area.

The IDC has also accorded approval that vacant plots already planned for IT Industry and plots to be re-planned for Institutional and Warehousing & Logistics uses out of these IT Industry plots in this industrial area Kanth Kalwar (Extn.) will be allotted by e-Auction, dispensing with the procedure prescribed in the rules for respective uses.






