- The Revised fees will be payable in new cases only, whereas old cases will be dealt
  with as per order dated 06-08-2002. The Fee will be paid by respective Unit Heads
  at their level without seeking further approval of the Controlling Officers.
- 3. Clerkage @ 10% of fees will also be paid to the panel advocates. Actual expenses incurred/to be incurred by Panel Advocates in attending cases will be paid to them. 50% of the fee will be paid after filing of Writ/Reply/Appeal/SLP/Suit etc. and balance 50% will be paid after final disposal of the case.
- 4. Panel Advocates will be paid 20% of the prescribed fees for court cases for tendering written opinion in the matters referred to them by Executive Director/Managing Director.
- 5. The Committee also authorised the Managing Director to sanction special fees in special cases in place of payable fees to the panel advocates and also to the Advocate General/ Additional Advocate General if required, looking to the urgency/importance of the matter.
- 6. The Committee also accorded ex-post- facto approval to the order No. Legal/Fee/4/08/437 dated 4-12-2013 issued in respect of payment of fees to Advovate General/Additional Genral of GoR and their assisting counsel appointed for and on behilf of the Corporation.
- 7. This Order will be applicable with immediate effect.
