OFFICE-ORDER

Note:-

1. Fees structures which has already approved by the Board of Directors and Managing Directors from time to time in the matters pertaining to Income Tax and Service Tax be treated as prescribed professional fee for the purpose of fee payable to the Tax Consultants/ Counsels to be engaged by the Corporation in Tax matters only, depending upon financial stake involved and merit of each case with prior approval of the Managing Director.
2. The aforesaid fee will be payable in new cases only, whereas old cases, if any, will be dealt with as per earlier order dated 06/08/2002 and 07/02/2014, as the case may be.
3. Other relevant provisions of earlier office order dated 07.02.2014 shall be applicable mutatis-mutandis.
4. This order has come into force with immediate effect.
