OFFICE ORDER (05/2019)


Sub: Partial amendment in the existing provision of the Rule 3(R) of RIICO Disposal of Land Rules, 1979 related to rate of allotment of land for Warehousing & Logistics to the Central/State Warehousing Corporation and also to include Rajasthan State Beverages Corporation Ltd. under the said category.

An agenda item (2) was placed before the IDC in its meeting held on 12.12.2018. The IDC has accorded approval for partial amendment in the existing provision of Rule 3(R) related to allotment of land to Central/State Warehousing Corporations as under;
