Minutes of the meeting held on 07.03.2017 at 11:30 am in RIICO Board Room, Udyog Bhawan, Jaipur, under the chairpersonship of Managing Director RIICO for finalization of Item (Schedule)/Category of Industries /projects allowed to be set up in the upcoming Industrial Area Mau, Tehsil Sri Madhopur under Sikar Unit as per EIA Notification 2006.

- B. At the outset, Unit Head Sikar presented the case before the Committee; explained the features of the land; need for developing the area and the type of industries expected to come up in the area.
- C. <u>The matter was discussed and after detailed deliberations following decisions were taken:</u>
- 1. Based on the industrial potential and availability of raw material in that region, industries based on agriculture products; cattle feed; wood work; stone cutting; cement based products and general engineering are expected to come up in this industrial area.
- 2. No plot will be allotted to Mineral/Stone Grinding units.
- 3. Since the area falls in over-exploited zone and notified block as per CGWA Notification, only non-water based industries to be allowed in this industrial area. Further, no water intensive industry shall be allowed in the industrial area.
- 4. Allotment of land should not be made to industry belonging to category "A" and "B" as per EIA Notification 2006.
- 5. Since the proposed industrial area is spread on 30 ha (less than 50 ha) and no plot shall be allotted to Category "A" and "B" industry, Environment Clearance is not required as per EIA Notification 2006.

- 6. As per approved planning of industrial area, development scheme of the entire land area (30 ha) will be prepared and accordingly Administrative & Financial Sanction will be obtained from the competent authority.
- 7. Subsequently, Unit Office will apply for Consent to Establish from RSPCB for the entire planned area based on the Administrative & Financial Sanction.
- 8. RIICO shall supply water for drinking & domestic purpose only.
- 9. It was further decided that:
- The proposed industrial area will be developed in phases. Initially, in first phase, development works in part of the layout plan containing plot No. G-59 to F-96 including the area earmarked for slurry dumping to be taken up (East Block). The plan is enclosed as annexure 'A'.
- Subsequently based on the pace of allotment in first phase, development in the remaining portion to be taken up after due approval of the Management.
- Dedicated zone comprising of plots from G-59 to H-86 to be earmarked for allotment to Stone cutting units only as they are close to proposed slurry dumping yard.
- 10. It was also decided that based on the various judgments/orders of Hon'ble Supreme Court/NGT/other Courts and for effective compliance of various pollution control & abatement measures as stipulated by MoEF&CC/ CPCB/RSPCB/CGWA/ other statutory agencies to ensure the protection and preservation of wholesomeness of environment, P&D Cell shall expedite necessary amendments/ additions/modifications in the RIICO Disposal of Land Rules and Lease Deed regarding the obligations on the part of allottees/lessee.
