It is further directed that Unit Offices should ensure that 'Bid' should be received in Bid Document as per **Annexure-1** and Site Report should be obtained in Performa as per **Annexure-2**. Non compliance of the above will be viewed seriously by the Management.

This bears approval of the Managing Director.


