OFFICE ORDER

Sub: Implementation of Solid Waste Management Rules, 2016 and E-Waste Management Rules, 2016 in RIICO Industrial Areas.

MoEF vide notifications dated 23.03.2016 and 18.04.2016 respectively have notified Solid Waste Management Rules 2016 and E-Waste Management Rules 2016. In order to make compliance of the relevant clauses of these rules in context of RIICO, following decisions have been taken by the management of the Corporation.

(A) Solid Waste Management Rules, 2016

- (1) In order to fulfill the compliance of *clause 11 (i)*, Contiguous 5 plots of 1000 sqm. each will be reserved in the planning of upcoming industrial areas for units involved in recovery and recycling facility.
- (2) In order to fulfill the compliance of clause (18), which is regarding the duties of the industrial units located within one hundred Km from the refused derived fuel and waste of energy plants based on solid waste, following action will be taken;
 - (I) The wide publicity of above clause shall be made in all industrial areas. This shall include providing copy of these rules to the Industrial Associations and taking up this matter in the DLAC Meeting headed by District Collector.
 - (II) In case of fresh allotments, following condition shall be inserted in the Letter of Allotment.

"That Industrial units using fuel and located within one hundred km from a solid waste based refused derived fuel plant shall use at least five percent of their fuel requirement by RDF so produced".

- (3) In order to fulfill the compliance of Clause (19) i.e. Criteria for Duties regarding setting up solid waste processing and treatment facility, following provisions in planning and in the Administrative Sanction of industrial area for scientific development of Non-hazardous solid waste disposal site shall be made:
 - (I) Earmarking land area for dumping yard in new industrial areas shall be as below;

Industrial Area Size	Land area to be earmarked for dumping yard
I/Area up to 25 hectare	0.5 hectare
I/Area 25-50 hectare	1.0 hectare
I/Area 50-200 hectare	2.0 hectare
I/Area more than 200 hectare	3.0 hectare

- (II) Above earmarked land shall be used for disposal of industrial solid waste (non-hazardous) from heterogeneous industries.
- (III) In case of stone based industrial area, need based extra provision for land exclusively for dumping of stone slurry/waste shall be made.
- (IV)) **Financial provision:** A provision of Rs. 100 lacs (with an annual increment of 5% on account of inflation) per hectare area shall be made for scientific development of dumping yard for industrial solid waste (non-hazardous) in administrative sanction for development of new industrial areas.
- (V) Earmarked/planned land will be given on **license basis** to SPV (created by beneficiary industries) for scientific development of the land as landfill/disposal site. The SPV shall also be responsible for its regular O&M.

(B) E-Waste (Management) Rules, 2016

In order to fulfill the compliance of clause 12 regarding Responsibilities of State Government for environmentally sound management of E-Waste, following decision has been taken;



- (1) For existing industrial areas, unit head shall identify and prepare list of vacant industrial plot of size 500-1000 sqm. In case plot size of 500 sqm. is available vacant then same will be reserved for allotment of E-Waste Dismantling and Recycling Industries, otherwise plot size of 1000 sqm. will be reserved. If plot of 500-1000 sqm. size is not available then unit office will explore possibility of re-planning the available vacant land/plot to create plot of above size.
- (2) For upcoming industrial areas, contiguous 2 plots of 500 sqm. each shall be reserved in the planning of upcoming industrial areas for units involved in E-Waste Dismantling and Recycling facility.
