### **OFFICE-ORDER**

## Sub: Clarification on the certain issues regarding Implementation of Salid Waste Management Rules, 2016 and E-Waste Management Rules, 2016 in RIICO Industrial Areas.

An office order no. IPI/P-3/24(F)-1/1728 dated 18.01.2018 was issued regarding Implementation of Solid Waste Management Rules, 2016 and E-Waste Management Rules, 2016 in RIICO Industrial Areas. In continuation to this office order, the following clarifications are being issued:-

- 1. In the specific purpose parks/ industrial areas like EPIP, SEZs, Japanese Zone, Agro Food Park, etc., the plots are allotted for specific product/ purpose, therefore, plot for Waste Recovery & Recycling facility and E-Waste Dismantling & Recycling units would not be planned in these specific purpose parks/industrial areas.
- 2. The industrial areas which have been opened/ to be opened for allotment after issue of the order dt. 18.01.2018 will be treated as upcoming industrial area for the purpose of implementation of relevant clauses {(A) (1) & (B) (2)} of the Office Order dated 18.01.2018
- 3. In case of existing industrial areas, if it is not technically feasible to carve out required size of plot even after exploring the possibility of re-planning of vacant plot/land available in the area then in this situation, plot would not be required to be reserved for E-Waste Dismantling & Recycling industries.

Further following decisions have also been taken by the Management:-

1. Earmarking of desired size planned plots for Waste Recovery and Recycling Facility in upcoming industrial areas and for E-Waste Dismantling and Recycling units in upcoming industrial areas as well as in existing industrial areas will be exercised by Unit Heads. Unit heads will earmark the plots in the lay-out

plan of concerned industrial area latest by 30.04.2018 under intimation to Advisor (Infra). In case any re-planning is required, then only proposals will be forwarded to Town Planning Cell, HO.

2. The Plots earmarked for the above purpose will be advertised by the Unit offices at the time of issue of advertisement in the new paper for the allotment/auction of plots as the case may be.
