OFFICE ORDER (11/2021)


Sub: Amendment in the existing provisions of Rule 3(I-a) of RIICO Disposal of Land Rules, 1979 related to allotment of land to Industries Associations in the industrial areas.

The IDC vide item (7) in its meeting held on 25.08.2021 has accorded approval for amendment in the existing provisions of Rule 3(I-a) of RIICO Disposal of Land Rules, 1979, as under:

3(I-a)	<p>1. Land measuring upto 500 sqm to one Industries Association in the industrial areas, depending upon their representative nature, involvement in industrial development etc. may be allotted for construction of the Association building:</p> <p>(i) At Rs. 1/- per sqm if a minimum investment of Rs. 500 crores has been catalyzed in the area.</p> <p>(ii) At 50% rate of allotment where Rs. 500 crores invested has not been catalyzed in the area.</p> <p>(iii) Land over and above 500 sqm shall be allotted at full prevailing industrial rate</p>	<p>1. Land measuring upto 500 sqm to one Industries Association in the industrial areas, depending upon their representative nature and involvement in industrial development etc., may be allotted for construction of the Association building at Rs. 1/- per sqm, dispensing with the process of e-Auction. Land over and above 500 sqm shall be allotted at prevailing rate of allotment of the industrial area concerned.</p> <p>2. Land to other Industrial Associations in the same industrial area may be allotted on the prevailing rate of allotment of the industrial area concerned, dispensing with the process of e-Auction.</p> <p>3.
