**OFFICE ORDER ( 06/2023)**


**Sub: Implementation of the budget announcement 2023-24 at point no. 198-III-(e) related to RIICO Amnesty Scheme-2023 and announcement made at point no. 25 of budget debate reply dated 16.02.2023 related to rebate in interest for depositing lump sum payable outstanding premium of land.**

In order to implement point no. 198-III(e) of the budget announcement and point no. 25 of budget debate reply dated 16.02.2023, an agenda was placed before the BoD by circulation. The Board has passed Resolution on the said agenda for implementation of above budget announcements. Accordingly, following rebates/ concessions /waivers by relaxing various provisions of RIICO Disposal of Land Rules, 1979, have been approved by BoD.

<b>S. No.</b>	<b>Rebates/concessions/ waivers by relaxing the relevant provisions of RIICO Disposal of Land Rules, 1979</b>
<b>(i)</b>	If the allottee deposits outstanding principal dues of service charges and economic rent in one go on or before 30.09.2023 then 100% recoverable interest on the outstanding principal dues shall be waived. However, the cases wherein outstanding dues with interest has already been deposited, shall not be re-opened.
<b>(ii)</b>	Rebate of 60% in payable interest, if the allottee deposits the installments of premium outstanding up to 30.06.2022 along with remaining 40% interest amount on or before 30.09.2023.
<b>(iii)</b>	In those cases in which allotted plot either has already been utilized or will be utilized upto 31.08.2023 as per rules, then in such cases, 80% amount of the applicable retention charges/Addl. Cost of Land for regularization of delay period shall be waived subject to deposit remaining 20% amount of retention charges/ Addl. Cost of Land on or before 30.09.2023. However, the cases wherein retention charges/Addl. Cost of Land have already been paid, shall not be re-opened.  In those cases where allotment of plot stands cancelled due to non-utilization within the stipulated/extended time period



The Board has also passed Resolution that above rebates/ concessions /waivers shall come into force **w.e.f. 01.04.2023.**
