OFFICE ORDER (23/2010)

Sub: Fixing the rate of development charges of contiguous industrial areas, uniformly

An agenda item on the subject matter was placed before the Board of Directors (BOD) vide item (15) of its meeting held on 17.08.2010. The Board has accorded approval to the recommendations of the Sub Group as earlier constituted by the BOD for recommending in the subject matter. Accordingly following directions are issued for contiguous industrial areas:-

- (i) In case the development charges in the newly developed industrial area are higher than that in the older industrial areas, the development charges in the older industrial area shall be brought at par with the new industrial area.
- (ii) In case the development charges in the older industrial area are higher than that in the new industrial area, the existing rates for the two industrial areas shall continue.

This order shall come in force with effect from 1.10.2010 but any pending application(s) which are backed by payment of requisite development charges shall be processed as per pre-revised rate of development charges.
