OFFICE ORDER (31/2010)

Sub: Special delegation of powers to officers of the Corporation along with relaxation in existing provisions of certain rules for expeditious disposal of land matters during Grievance Redressal Camps at unit office level and also relaxations in the existing rules / policy relating to regularization of strip of land and unauthorized construction in industrial plots as an amnesty scheme.

An agenda item on the subject matter was placed before the Infrastructure Development Committee vide item (11) of its meeting held on 18.10.2010. The Committee has accorded approval for special delegation of powers to officers of the Corporation along with relaxation in existing provisions of certain rules/policy for expeditious disposal of land matters. However, special delegation/relaxation which are mentioned below at point no. 1 shall be in-force only during the period of Grievance Redressal Camps being organized between 19.10.2010 to 31.12.2010.

It is further clarified that as per approval accorded by the IDC vide item (1) of its meeting held on 2.11.2010, relaxations mentioned at point no. 2 and 3 would be exercised by the unit offices during the period from 19.10.2010 to 31.12.2010 irrespective of camp dates.

1. Special Delegation of Powers and relaxation in existing provisions:

The existing delegations, the new delegations of powers to the officers and relaxations are as under:

2. **Relaxation in the existing rules / policy for regularization of existing unauthorized construction in industrial plots as an amnesty scheme:**

Re-launching of amnesty scheme for compounding of unauthorized construction in industrial plots which was earlier launched in the month of February, 2009 and valid up-to 31.03.2010. Unit Heads are authorized to approve the proposal as per the provisions of the above scheme irrespective of the period during which the unauthorized construction was done. The unit offices will launch a drive for the same and give wide publicity.

3. **Relaxation in the existing rules / policy for allotment/regularization of strip of land in allotted industrial plots as an amnesty scheme:**

Re-launching of amnesty scheme for relaxation in the existing rules / policy for allotment/regularization of strip of land in allotted industrial plots which was earlier launched in the month of February, 2009 and valid up-to 31.03.2010. Allotment /regularization of strip of land at the level of Unit Heads is hereby allowed as under:-

- (a) Regularization of excess land up-to the extent of 10% of the allotted land area on prevailing rate of the industrial area concerned.
- (b) Beyond 10% of allotted land area, excess land will be regularized at 1.25 times of the prevailing rate of the industrial area concerned.
- (c) In case of auctioned industrial plots, excess land up-to 10% of the allotted land will be regularized on auction rate or prevailing rate of development charges, whichever is higher.
- (d) Beyond the land area mentioned at (c) above, excess land will be regularized at 1.25 times of the auctioned rate or prevailing rate of development charges of the industrial area concerned, whichever is higher.
- (e) All other existing technical riders will remain intact.
