OFFICE ORDER

The Working Committee of the Board in its meeting held on 24th June 2020 vide item No. 12 has accorded approval for the following changes in the schedules for the posts of Programmer-cum-Operator and Computer Operator-cum-Sr. Assistant:

- (A) (i) The name of the post of Programmer-cum-Operator be re-designated as Programmer.
- (ii) The mode of recruitment on the post of Programmer be amended to 70% -30% direct quota and selection quota respectively against to the earlier 60%-40% direct quota and selection quota (promotion quota) respectively.
- (B) (i) The name of the post of Computer Operator cum Sr. Assistant be re-designated as Assistant Programmer.
- (ii) The mode of recruitment on the post of Computer Operator be amended to 100% direct quota against to the earlier 50%-50% direct quota and selection quota (promotion quota).
