**Sub: - Tariff of RIICO Guest House at Bhiwadi Industrial Area.**

The Management of the Corporation has been pleased to accord approval of Tariff for RIICO Guest House at Bhiwadi Industrial Area, as below:-

**Special Terms & Condition:**

1. All the booking including VIP Suites shall be made with the approval of Managing Director/ Executive Director RIICO. However, for the booking of RIICO officers, the Unit Head will be empowered to book upto their stay of maximum 3 days.
2. \* Tariff for Guest rooms from existing allottees of Bhiwadi Industrial Areas under jurisdiction of Bhiwadi Unit-I & II shall be charged by allowing 20% rebate.



**Other Terms & Condition:**

1. Above rates are applicable for stay upto 15 days, for next 15 days charges would be increased by 50% and after 30 days stay would be not allowed. However, the stay can be extended further with permission of Chairman or Managing Director but beyond 30 days stay, double the normal rates would be chargeable.
2. Accommodation in the guest house would be required to be booked at least 3 days in advance.
3. There would be no fixed check-out time. However, the charges would be applicable on stay of each hour period or past of thereof exceeding 4 hours.
4. In case the stay is upto 4 hours, 50% amount would be charged for that day.
5. Security deposit for hiring of conference hall for Govt. Department shall be Rs.1000/- and for private persons Rs.2000/-. The same would be refunded after satisfactory handing over of conference hall.
6. GST shall be charged extra, whenever applicable.
