The Committee noted the position brought out in the agenda note.

Item 3: Administrative Sanction for development of new Industrial
Area Mathasula Phase-II, Unit office Jaipur (Rural).

The Committee discussed the agenda and accorded approval of Administrative Sanction for development of new Industrial Area Mathasula, Ph-II, Unit office Jaipur (Rural) at an estimated cost of Rs. 2924.32 lac.

The consideration of agenda item was deferred.


Item 6: Administrative Sanction for development of New Industrial Area Chadual, District Sirohi, Unit office Abu Road.

Item 9: Revision in Administrative Sanction for development scheme of Industrial Area Hukkan, Unit Office EPIP Sitapura, Jaipur.

The Committee discussed the agenda and accorded approval for revision in Administrative Sanction for development scheme of Industrial Area Hukkan, Unit Office EPIP Sitapura, Jaipur from Rs. 3372.57 lac to Rs. 4585.81 lac, as per details given in 'Annexure-A' to the agenda note.

Item 10: Administrative Sanction for development of New Industrial Area Boranada Extension, Unit office –Boranada.

The Committee discussed the agenda and accorded approval for Administrative Sanction for development of New Industrial Area Boranada Extension, Unit office –Boranada, with an estimated cost of Rs. 98,909.80 lakh, as per details given in Annexure 'A' to the agenda note.

The Committee noted that following agenda items were placed on the table with the permission of the Chair, therefore the members present in the meeting unanimously agreed to waive the minimum notice period, took up the item for consideration and approved unanimously.

Item 11: Time extension for depositing 100% amount of land premium along with security money and other miscellaneous charges to HPCL to whom Plot No. SP-144 at Industrial Area, Bagru, Chittroli was offered on 11.12.2023.

The Committee discussed the agenda and accorded approval to allow HPCL to deposit 100% land premium along with the security money and other miscellaneous charges without interest within 7 days from the date of receipt of the demand notice from the Unit office Jaipur (South).

Item 12: Re-examination of ex-post-facto approval of the decision taken by IDC in its meeting dated 21.9.2023 regarding partial amendment in the terms and conditions of allotment letter no.

U(29)/2007-2008/2354 dated 08.08.2007 for allotment of land for development of Exhibition ground in addition to the existing R&D Cum skill Up-gradation Centre for Handicrafts and Guar-Gum products etc. at EPIP, Boranada, as per directions of IDC in its meeting dated 27.03.2024.

The Committee discussed the agenda and accorded approval to the recommendations of the Committee as under:

"The allotment made to Industries Department in the year 2007 for setting up of R&D Cum Skill Up-gradation Centre for Handicrafts and Guar-Gum Products and further allowed for exhibition ground in the year 2023 may be withdrawn".

Item 13: Additional Administrative Sanction for up-gradation of Road Infrastructure at I/A Bhiwadi, Unit office Bhiwadi-I.

The Committee discussed the agenda and accorded approval for Construction of CC road and Construction of BT Road at I/A Bhiwadi, Unit Office Bhiwadi-I. The Committee deferred the consideration of Construction of Paved Shoulders with Interlocking Tiles with the directions that a Vision Specific Scientific Study is to be carried out to examine the impact on air pollution after completion the proposed interlocking tile work.

General Observations:

The Committee has directed to monitor on periodical basis for civil works regarding the projects sanctioned by the Corporation having value of more than Rs. 1 crore. In the said monitoring, the details of the work orders given by the Corporation, date of sanction of the project, estimated date of completion, extension given if any, reason for delay in completion of project, remarks of Controlling Head etc. should be reviewed. Quality control including taking samples for testing and preservation thereof of each major project should also be monitored vigorously by the Civil Wing. The periodical reports of such review shall be placed before IDC through management for perusal. Besides it, Bid capacity formula should also be compared with other works department

like PHED, Housing Board, JDA, Nagar Nigam etc. and after the study of their models, the necessary changes in the norms of RIICO be incorporated. The standard draft of Contract Agreement Bid documents etc. should also be reviewed and modified suitably.

The meeting concluded with a vote of thanks to the Chair.
