"Reservation of vacancies for Backward Classes and More Backward Classes shall be in accordance with the orders/notifications of the State Government for such reservation in force at the time of direct recruitment. In the event of non-availability of eligible and suitable candidates amongst Backward Classes and More Backward Classes in a particular recruitment year, the vacancies so reserved for them shall be carried forward to the subsequent three recruitment years. three expiry of After the such carried recruitment vears. filled in forward vacancies shall be accordance with the normal procedure;

Amended Rules

ANCIES FOR BACKWARD AND MORE

Provided that :-

- if recruitment is not held in any recruitment year, such recruitment year shall not be counted for the purpose of this rule.
- (ii) Filling up of the vacancies in accordance with the normal procedure under this rule shall not affect the reservation of posts as per the post based roster and vacancies on the reserved posts available in the roster may be filled in amongst the persons belonging to the Backward Classes and More Backward Classes, as the case may be, for which such vacancy is available in the subsequent years.
