**OFFICE ORDER**

**Sub: - Ex-post-facto approval for revised cost of Power Infrastructure (Charging Feeder) to be setup for the upcoming Industrial Township in JPMIA-SIR under the DMIC project in Rajasthan.**

Earlier an agenda was placed before the Board of Director in its meeting held on dated 04.09.2025 related to establishing power infrastructure up-to-the project site Industrial Township in JPMIA-SIR regarding Power infrastructure (Charging Feeder to be set up for the upcoming Industrial Township in JPMIA-SIR under DMIC Project in Rajasthan). The Board has accorded approval to make payment of Rs. 87.21 crore (including GST) to Rajasthan Rajya Vidyut Prasaran Nigam Limited and accordingly sanction of Rs. 87.21 crore was issued on dated 18.09.2025 and part payment of Rs. 11.51 crore made on 19.09.2025.

RVPNL floated tender for execution of this work and reported revised cost Rs. 130.77 crore and consent on revised cost was communicated on dated 15.12.2025 to RVPNL.

Due to revised cost agenda was again placed before the Board of Directors of RIICO for Ex-Post Facto approval. The Board of Directors of RIICO in its meeting on 22.12.2025 vide item No.19 accorded Ex-Post-Facto approval for the following: -

1. Communication issued by RIICO to RVPNL vide letter dated 15.12.2025, conveying consent to bear the revised cost of the power infrastructure work amounting to 130.77 crore.
2. Authorizing the CEO, JPMIA-RDA and managing director, RIICO to take decision in the matter, including financial approval of the work up to +-5% of revised cost of 130.77 crore, subject to the final bill raised by RVPNL
