OFFICE ORDER

Sub: - Rate of Service Charges for the F.Y. 2026-27.

The Management of Corporation has decided to revise the Rate of Service Charges for the F.Y. 2026-27 as under:-

1. The rate of Service Charge for the F.Y. 2026-27 are to be calculated by increasing the Services Charges rate of the F.Y. 2025-26 by 10% subject to maximum of ₹13/- per Sqm. and minimum of ₹1000/- for an industrial plot. (The rate of services charges has been rounded off to nearest 10 paisa.) However, maximum ceiling of ₹13/- per sqm. will not be applicable in case of SEZ/EPIP. Levy of service charges in respect to commercial and residential plots shall be made as per rule 15 (A) (ix) & (x).
2. For following industrial areas which are falling in category-'C' where water supply scheme was planned/commenced earlier but subsequently abandoned, Service charges be levied at revised rates of services charges worked out as per (1) above or ₹6.70 per sqm., whichever is less:-
